NOTICE OF PUBLIC HEARINGS ON FIRE PROTECTION CONTRACTS  
FOR THE YEAR 2022**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Town Board (“Town Board”) of the Town of Windsor (“Town”) on Wednesday, November 3, 2021, commencing at 7:00 PM at the Windsor Town Hall, 124 Main Street Windsor NY, for the purpose of considering new fire protection contract with Windsor Volunteer Fire Department and West Windsor Volunteer Fire Department. The contract shall be upon the following general terms, to wit:

The above-named entities, at all times during the period of said contract, will be subject to call for attendance upon any fire call occurring in such areas, and shall respond and attend upon all fire calls in said areas.

For such services, payments shall be made by the Town pursuant to said in the sum of \$25,175 to Ouaquaga Fire Co. (Two certain areas of Town Fire Protection District No. 1). The contract shall continue for a period of five years, from January 1, 2019 until December 31, 2023. The contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.

For such services, payments shall be made by the Town pursuant to said in the sum of \$134,813 to West Windsor Volunteer Fire Department, Inc. (Town Fire Protection District No. 2). The contract shall continue for a period of one year, from January 1, 2022 until December 31, 2022. The contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.

For such services, payments shall be made by the Town pursuant to said in the sum of \$134,813 to Windsor Volunteer Fire Department, Inc. (Town Fire Protection District No. 3). The contract shall continue for a period of one year, from January 1, 2022 until December 31, 2022. The contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.

For such services, payments shall be made by the Town pursuant to said in the sum of \$9,018 to Windsor Volunteer Fire Department, Inc. (Town Fire Protection District No. 4). The contract shall continue for a period of one year, from January 1, 2022 until December 31, 2022. The contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.

Copies of the proposed contract are on file and may be examined at the office of the undersigned Town Clerk. All persons interested in the matter will be heard at the above-described public hearing. Individuals have the right to provide written and oral comments and ask questions concerning the proposed contracts or any portion thereof. Handicapped individuals or senior citizens who require assistance in attending said public hearing, or in furnishing comments and suggestions, should contact the undersigned Town Clerk to request such assistance.
