- In the email state the name on the parcel, the tax id#, and the email address to send it to.

Please Note:

- **Partial Payment Option:** At least one-half of the "Total Amount Due" must be paid in the month of January. The remaining balance must be paid in one payment by **March 31, 2021** (penalty of 1% of the remaining balance during the month of February, and 2% during the month of March).
- **January** payments are penalty-free. **Last day to pay is February 1, 2021**
- **1% late fee** will be added to the bill beginning February 2, 2021. **Last Day to Pay is March 1, 2021.**
- **2% late fee** will be added to the bill beginning March 2, 2021. **Last Day to Pay is March 31, 2021.**
- As of **April 1, 2021**, no payments can be accepted by the Town of Windsor Tax Collector.

Reminders:

- \$20.00 fee charged on all returned checks
- US Post Mark will be accepted as long as the physical date is stamped on envelope ***Note: Some online payment companies do not postmark on envelopes; in these cases, the payment is considered received on the date it arrives to Tax Collector's office.**
- We accept Cash, Personal Check & Money Order for Payment (***No Post-Dated Checks**)
- Payee on check must be: "Town of Windsor Tax Collector" if it is not your check will be returned and could result in a late payment.
