#### **HISTORY:**

Town Historian, Rita Saunders updated the Board on the activities of the History room. Rita has been spending a lot of time this summer working in the cemeteries in Windsor. One project has been updating the listing of Veterans Graves in Windsor cemeteries, she has been working with Gail Bagg from Riverside cemetery. Rita recognized resident Jeremy Rounds for cleaning up the leaves and branches at Doolittle cemetery on Route 79 as well as creating a listing of all the names on the graves that were in there that could be read. Rita has also been to the Mountainview Cemetery where the Fiore's have been working on repairing stones of their family members and she said the work is amazing that they do. The bulk of this year she has been working on going through 148 years of Windsor Standards and has them in order in archival boxes so they can be digitized next. Councilman Price asked if there was funding for this, the Town Clerk responded that they had already looked into a few avenues and there are quite a few organizations that fund this.

This week with the assistance of the summer interns she has gotten all the photographs sleeved and the metal clips replaced with plastic ones in all of the family files in the history room and thanked Councilman Price for his efforts in finding out about this program with the youth.

#### **SENIOR CITIZENS:**

### TOWN CLERK/REGISTRAR:

The Town Clerks June 2023 report was given to the Board there were no questions, the Clerk said there was nothing of interest to mention. The office renovations are currently underway and things are going smooth.

#### **TOWN HALL:**

Supervisor Odell informed everyone that Judge Dadamio from the Town of Fenton has been assigned to assist with the Court caseload until the end of the year.

#### **WASTEWATER TREATMENT PLANT:**

John Mastronardi from Griffith Engineering told the Board he has been looking into another option for the sludge removal that may not be as costly. John found where this has been done without disturbing the reeds or damaging the mem brane, he is still researching it but thinks it may work and we be a large cost savings for the Town. The first thing that has to be done is have a sample tested to see if it meets the requirements for hauling to the local landfill or if it will require a specialized hauler from further away, so he and Donnie are going to get that taken care of so the Town knows what type of hauler to go out to bid for. John said he thinks it will be two fees that will need to be paid, one for the hauling to the hauler and the tipping fee to the landfill because the weight will be unknown.

#### **YOUTH & RECREATION:**

Rhea Deyo from WYSR gave an update on the Spring/Summer sports season, stating they have had the largest numbers ever and they continue to grow. The annual Easter egg hunt and Opening Day were both successful events. The Opening Day parade route was changed from commencing down Route 79 and closing traffic for a significant amount of time, they chose to walk from the middle school up Grove Street to the park, Rhea said both parents and players were very happy. There are currently a few summer baseball, softball and lacrosse teams playing now, and the fall football practices have begun.

Amanda Jackson, Stacie Congdon and Jason Colwell gave an update on the Windsor Town Fair. Amanda shared they have 20 sponsors for this year's event and had \$12,000 profit from last year going into this year. There are 5 more fundraisers before the fair still and they are in need of an additional \$5,600 to go into this year to break even. They have added more events this year and expanded the locations of the events to the mud flats on Bridge Street and behind the middle school. The Parade will have some new additions as well as a float contest with cash prizes and they have 3 mystery judges for this event. There is a possibility of a Nashville recording artist coming to perform as well but they are not sure yet. Councilman Hupman asked if they have been doing a lot of out area advertising to pull people in. Amanda said they have some PR events coming up. Amanda also wanted to share with the Board that, Michael's Sensory Space, which was created for last years fair was invited to come this year to both the Conklin and Kirkwood Town Fairs.

### ZONING, PLANNING & CODE ENFORCEMENT:

The Board reviewed the Code Officers June 2023 report, there were no questions. Code Officer Osbourne wanted to give the Board some information that he has been tracking about where his time is spent when he is working for the Town. In the month of June 43% of his time was spent dealing with issues with stone quarries.

Code Officer Osbourne also wanted to bring to the Board an issue the Fire Departments brought to him. Often times when fire crews are fighting fires, they need to have someone come knock part of the building down so they can ensure the fire is out. Last week they responded to a garage fire on Hoadley Hill Road that they were called to return to four times that evening because it reignited. The fire chief told Code Officer Osbourne that other municipalities will have a contractor on call for this situation and wanted the Town to look into. Councilman Harting said he would contact the County Emergency Services and ask what they suggest and get back to the Board with the information.

Code Officer Osbourne also submitted his completed service training hours are complete through 2024

The Board discussed a petition that was received from residents of Beaver Lake in regards to a pending quarry permit on Beaver Lake Road. Councilman Harting asked Attorney Spinner if there is a set number of petitions that can come to the Town before they have to act or not. Attorney Spinner stated that there is actually no required action that has to be taken with any petition. Deputy Supervisor Colwell stated that the facts are that in the Town mining is a permitted use of land however he does feel that it can be more closely regulated as part of the SEQR process. Code Officer Osbourne stated that the Town laws are not in existence that would allow the Town to have more control over this situation and that is where the frustration occurs for residents. Code Officer Osbourne feels that the Town is not being served by the D.E.C. and they help to excuse the violations of the quarry owners. Attorney Spinner said that with mines the D.E.C. handles all quarries and mining permits, in order to make this more restrictive the Town needs to change its zoning law to prohibit mining in an agricultural district so that every applicant would have to go before the ZBA for a variance, when they do that then conditions can be set forth by the Town for the business and there is something for the Code Officer to enforce. Attorney Spinner said at this time the only thing that can be done for the quarry on Beaver Lake Road at this time is to respond to the D.E.C.'s notification that they are to lead agency on the SEQR review that the Town has concerns and wants input before the mine permit is issued. Councilman Harting asked if the Town could require a Special Use Permit and Attorney Spinner said that is exactly what the Town can do, lay out their concerns and request that the D.E.C. establishes a point of contact for complaints that will be accountable to the Town.

The Board also addressed an email that Supervisor Odell received over the weekend from Evelyn Klie over the weekend about a stone cutting shop that was sawing nonstop all weekend long on Mcallistor Road. Mrs. Klie had stated in her email that the sawing began early Saturday morning and continued until 7:30 P.M. on Sunday she drove up into the quarry looking to speak with someone and found this large stone saw running with no one around at all. Supervisor Odell attempted to go to the quarry on Sunday and found the gate locked and no one around. Code Officer Osbourne reported that he had issued a stop work order because they do not have a quarry permit and stone sawing is manufacturing which is not allowed in an agricultural zone. If they continue, he contacts the Sheriffs office to issue a summons to court. Supervisor Odell appointed Councilman Harting and Councilman Hupman along with Code Officer Osbourne to review the zoning and determine where the changes need to be made for so the Town can have more recourse for these situations and protect its residents. Deputy Supervisor Colwell asked to be able to consult with the committee as a quarry owner/operator himself he could add some insight.
