## **PUBLIC HEARING:**

Supervisor Odell reopened the adjourned hearing for Local Law to Exceed the Tax Cap at 7:02 P.M. there were no public comments, Supervisor Odell made residents aware the Town would not be exceeding the tax cap the hearing was closed at 7:03 P.M.

Supervisor Odell reopened the adjourned public hearing for The Hills of Windsor Proposed Project at 7:03 P.M. David Cox from Passero Associates gave the Board an update from last month on changes that were requested. They decreased the grade of the access driveway as recommended, they have also made changes to the storm water pond and verified that all roads have passable turning abilities for firetrucks. Town Engineer, John Mastronardi voiced concern due to an incomplete SWPP report that has been submitted and the Geotech report is missing infiltration or peculation testing that has been asked for. Deputy Supervisor Colwell asked when it was expected to be completed, David Cox said that it is on the list for the Geotech to get done he is hopeful that it will be soon. Code Officer Osborne asked what was happening with the request from NYS DOT with the access driveway. Cox stated he had inquired with DOT and they do not foresee an issue as there was an existing driveway which they were told could be reused. Supervisor Odell adjourned the Public Hearing until the October 4, 2023 Regular Meeting.

Supervisor Odell invited Holly Gruskay & Linda Burghardt to present on behalf of New York Citizens Audit. This is a grass roots campaign seeking support from localities across the State to prevent voter fraud. New York Citizens Audit is asking that the State Board of Elections to make voter rolls accurate and ensure that the number of votes counted equals the number of voters voting. Mark Ponzi of Endicott shared that he had run for office in the Village of Endicott and lost by 5 votes, small municipalities are where these errors can make a difference and it is also diluting the votes in larger elections. The Board supported their efforts and applauded them for the work they are doing.

## **ENGINEER:**

John Mastronardi from Griffiths Engineers gave an update on the new highway building. All contracts have been returned signed, and he has the contractor's calendar. The contractors, Engineer and Highway Superintendent Kithcart had a meeting today and they will be breaking ground tomorrow. Supervisor Odell asked how this would work when winter comes and the ability for the Highway Department to still operate while construction is going on. John said that was discussed in the meeting and everyone is aware this will be essential. Deputy Supervisor Colwell asked when the building was scheduled to be delivered, and asked if the January 1st date that was originally set in the contract would be met. John Mastronardi shared that at this time the building delivery is expected December 4,

2023, however when the redesign for the heat system was done that set the January 1<sup>st</sup> deadline back quite a bit. At this time the contractors anticipate completion in April or May of 2024. Deputy Supervisor Colwell requested that Griffiths watch for change orders that might cost taxpayers more to have the work done through the winter. John stated that footings and most concrete work should be done prior to any heavy frost according the calendar.

Supervisor Odell asked about the reed bed project at the Waste Water Treatment Plant, John said he had reached out to Don Sherwood to see if the sample testing results had been returned. The materials need to be classified before Griffiths can get an estimate for this project.
