Supervisor Odell shared the Towns Fiscal Stress Score from the Comptroller's Office happy to report that the Town is in good standing.

The Board reviewed the 2024 Tentative Budget, Supervisor Odell thanked Deputy Supervisor Colwell and Secretary to the Supervisor, Khristine Breeding for all their hard work in order to keep the budget within the tax cap. Councilman Harting asked how the budget numbers worked when the contracts are negotiated after the budget passes. Supervisor Odell and Secretary to the Supervisor, Khristine Breeding stated they had spoken with the fire departments and they agreed to the amount that is budgeted and in return the contracts have been adjusted to require these entities to provide their financials to the Board yearly. Supervisor Odell expressed to the Public how difficult it is for municipalities to keep up with the increases in the cost of goods.

Councilman Harting brought awareness to the amount of money that is set aside for road repairs in the Town. Stating one of the most common complaints Townwide is the condition of roads, and y taxes are collected for the Town to provide the service of maintaining roads and if the budget amount is not increased for this item the Town will never be able to keep up with repairs.

The Board reviewed the Clerks September 2023 report Deputy Supervisor Colwell asked about the revenue from DEC licenses and the Clerk stated she believed it was 1 ½% commission on sales.

Councilman Harting asked about the additional computer for the Clerk's office and the tablet for the Code Officer, Clerk Pfister informed everything was ordered after the approval at last months meeting and just waiting for it to come in.

Supervisor Odell questioned what the monthly charges are for from the Computer Shop and questioned if anything was overlapping where we could cut back on spending. Councilman Harting explained that all computers in the building funnel through the Clerk's computer so their information is backed up on the cloud daily and that the Clerk's and Secretary to the Supervisor's computers had remote access and these are requirements of the Town's IT Policy.

### **TOWN HALL:**

The Town Clerk read a Thank You card from the Stapleton Family after Justice Stapleton's passing.

Supervisor Odell asked how the split systems were working in the building as we head into winter, Code Officer Osborne and the Clerk had turned boiler back on to keep building from having pipes freeze during off hours as cold weather starts to set in.

Supervisor Odell thanked the Clerk and Holly Gardinier for submitting for the Broome County Small Communities Grant for the exterior work on the Town Hall.

### **WASTEWATER TREATMENT PLANT:**

Councilman Hupman questioned the status on the reed bed project at the plant, Supervisor Odell has been speaking with the Engineer they are still awaiting the sample testing so it is determined where the waste can be dumped and then he will be able to price out the job.

## YOUTH & RECREATION: None ZONING, PLANNING & CODE ENFORCEMENT:

The Board reviewed the September 2023 Code Report, nothing to note. Code Officer Osborne asked about the progress with updating the Code books. Code Officer Osborne shared that there has been difficulty trying to find laws on the books when residents call in order to know the procedures to follow and both the Code Officer and the Town Clerk had spent a lot of time looking for the information. Supervisor Odell said he called Bob Williams, Zoning Chair and he had a call out to Shelly Bennett, Planning Board Chair and is waiting a call back to schedule a meeting. Councilman Harting shared that the Clerk had gotten a quote from Williamson for a Code program but it was not what we were looking for. There are companies that do update the Code for you and will maintain it as well for a fee but it is costly to have done.

Deputy Supervisor Colwell shared he had spoke with D.E.C. representatives and is concerned that the Town is very restricted on what they can regulate for mining. Code Officer Osborne and Attorney Spinner stated that the Town is not trying to control any of the regulations, what the Town wants is to have input and oversight of any project which we currently do not have. Code Officer Osborne shared that since this dialogue has been opened things have already improved with the D.E.C.
