FOR THE YEAR 2024**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Town Board (“Town Board”) of the Town of Windsor (“Town”) on Wednesday, November 1, 2023, commencing at 7:00 PM at the Windsor Town Hall, 124 Main Street Windsor NY, for the purpose of considering new fire protection contract with Windsor Volunteer Fire Department and West Windsor Volunteer Fire Department. The contract shall be upon the following general terms, to wit:

The above-named entities, at all times during the period of said contract, will be subject to call for attendance upon any fire call occurring in such areas, and shall respond and attend upon all fire calls in said areas.

For such services, payments shall be made by the Town pursuant to said in the sum of \$137,609.26 to West Windsor Volunteer Fire Department, Inc. (Town Fire Protection District No. 2). The contract shall continue for a period of one year, from January 1, 2024 until December 31, 2024. The contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.

For such services, payments shall be made by the Town pursuant to said in the sum of \$137,509.00 to Windsor Volunteer Fire Department, Inc. (Town Fire Protection District No. 3). The contract shall continue for a period of one year, from January 1, 2024 until December 31, 2024. The contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.

For such services, payments shall be made by the Town pursuant to said in the sum of \$10,018.00 to Windsor Volunteer Fire Department, Inc. (Town Fire Protection District No. 4). The contract shall continue for a period of one year, from January 1, 2024 until December 31, 2024. The contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.

AMBULANCE SERVICE AGREEMENT FOR THE YEAR 2024**

NOTICE IS HEREBY GIVEN that the Town Board of the Town of Windsor will conduct a public hearing on November 1, 2023 commencing at 7:00 P.M., at the Windsor Town Hall, 124 Main Street, Windsor, NY, with respect to a proposed agreement between the Town of Windsor and Windsor Emergency Services Inc. (“Squad”), pursuant to which Squad agrees to furnish emergency medical ambulance services within the Town of Windsor, for the period beginning on January 1, 2024 and ending December 31, 2024. The total payments to be made by the Town to Squad under the Agreement shall be \$208,437.00 Those payments include: (a) a sum not to exceed \$8500.00 which represents the amount to be raised by real estate taxes for ambulance services, and (b) a sum not to exceed \$199,937.00 being the estimated proceeds from Squad billing.

The proposed Agreement for Ambulance Service is on file and may be examined in the office of the undersigned Town Clerk.
